Matthew Carey, Superintendent – I recommend the Board consider but we are not forcing anything. I have used this in previous districts and workflow makes it more efficient. It's easier for users to build an agenda and we would be in compliance with archiving the agendas.

Ms. Vena – I do like to look back to determine when a conversation happened.

Mr. Stockman – I sense it is the essential way, but I am not as tech savvy but if you recommend this I'm ok to move forward. Not sure if there are other competitors.

Mr. Wareham – There would be implementation training for publishers and viewers training. Members would need to learn the log in process.

Ms. Morgan Santo – I suggest we table and give all board members time to think it through – pros and cons: Pro - if there is a question on a previous agendas we can look it up easily

Con – at home not having printing capabilities or technical assistance, so that's a drawback to having it in print.

I don't want anyone at a disadvantage, as it takes time to go through the agenda or take a note.

Dr. Angwenyi – I agree to give people a chance to go through. This will be a learning curve and not everyone will be in the same place. Overall good features and potential benefits.

Mr. Stockman - Can we put this on the next agenda?

Ms. Morgan Santo – No we will table and get questions answered.

Mr. Wareham – We can archive as far back as needed.

Ms. Donnelly noted the ransomware issue at Mercer County Technical Schools which prohibits us from easily researching – this would've prevented issues.

Mr. Wareham – There would be a 2-month roll-out and run concurrent for a time, then go fully digital in the future. Also, attachments do not print when printing the agenda.

Ms. Morgan Santo – Mr. Carey, what do you feel is appropriate?

Mr. Carey – I agree to table this item, open a dialogue to answer any questions. We didn't bring this to rush it. Our current system isn't broken.

Ms. Morgan Santo – Where should members send questions?

Mr. Carey – Send questions to Debbie Donnelly as the Board Secretary.

Mr. Stockman – It makes sense to give everyone a chance. I see it as inevitable. The staff is on board but board members not yet. Do we need a committee?

Ms. Morgan Santo – No committee. Just direct questions to Debbie (Donnelly).

Ms. Donnelly – Yes, I will collect the questions and provide a Q&A response.

Mr. Wareham – I will send a few examples of other districts using this program.

Mr. Carey - This is recommended by the NJ School Boards Association and was used at my former district.

Ms. Vena – Remember, committees of the whole meetings – all members but no other meeting items – informal, no action.
